

Sub: **Extension of date for uploading of photographs in the registration data.**

Sir/Madam,

Kindly refer to letter No. CBSE/CE/SPS/2018 dated 26.10.2018, wherein the correct procedure for uploading the photograph has been intimated. It has been observed that maximum data alongwith photographs has been uploaded by the schools for registration of their students in Class-IX and Class- XI However, few schools are still left for uploading of photographs. Accordingly, following has been decided: -

1. Schools may submit the **registration data** and pay the fee today by midnight. These schools may upload the photographs by 5.11.2018 to complete the process.
2. Schools who would upload the data tomorrow i.e. on 01.11.2018 and thereafter, earlier schedule will apply to them and they will be charged late fee as applicable and communicated.
3. In case of List of Candidates, Schools are requested to complete the process as per schedule as CBSE is in the need of data and photographs early to make the preparations for February/March examinations.
