
Several initiatives have been taken by the Government of India to promote sports amongst youth. CBSE has also mainstreamed Health and Physical Education at Secondary and Senior Secondary levels by introducing a mandatory period per day for sports, games, etc.

To further promote sports, CBSE took a decision in March 2018 to facilitate such students who are participating in International Sports Events and studying in CBSE affiliated schools in Class X or XII for the purpose of appearing in the Board's examination. This facilitation was extended to all those cases where Board examinations were coinciding with their participation in any international sports event. In the last Board exams held in March-April 2018, this facilitation was extended to 9 students.

It has been decided to make this a policy decision and extend such facilitation hereon to all such students whose CBSE Board exams clash with their participation in any international sports event that is recognised by Sports Authority of India and the student participates as a representative of India. For such students, their examination will be conducted at a later stage, at a date mutually convenient to the student and the Board, however before declaration of Board results.

Such students may make a request in writing to the CBSE through their schools alongwith the recommendations from the Sport Authority of India informing about the participation in the international events on the date of examination or near the date of examination. Schools are requested to communicate such cases to the concerned Regional Office of the CBSE by 31st January, 2019. Recommendations from Sports Authority of India may be given in the annexed format.

Schools may please bring this information to the notice of their students who are actively participating in competitive sports and are likely to participate at an International Sports Event so that they can be benefitted.
