**Sub: Extension of date with normal fees for registration in Classes IX & XI - regarding**

**Madam/Sir,**

Preparations of the Boards examinations started a year in advance with the process of registration of students in Classes-IX and XI. This helps CBSE in informing the magnitude at which preparations are to be made next year. Accordingly, registration process was announced and schedule was communicated to the schools.

From various sources, it has come to the notice of the CBSE that schools and Parent are facing problems in completing registration process because of the situation created due to Covid-19 pandemic and have also been communicated these to the CBSE.

Looking into the problems faced by schools and parents, CBSE has decided to extend last date of registration in Classes-IX and XI. The last date with normal fees for registration for Classes IX & XI is 04.11.2020. Now last date with normal fees has been extended upto 19.11.2020. Revised schedule is as under:
